Reshipment of replacement labels will be made by UPS 2nd Day Air. (U.S. only) While every effort is made to remain within delivery guidelines, NWTL assumes NO

responsibility for specific ship dates. An expected ship date is a projection and may vary due to circumstances beyond our control. NWTL accepts no financial liability for delivery beyond published projections. Limits of product liability extend solely to the replacement of defective or incorrect labels and cannot exceed that cost. Customer agrees to repackage defective or incorrect labels for pickup by UPS, as directed by NWTL.

Why don't we mail packages? Dropping your label order in the mail sends it out with no method of tracking the package. If it doesn't arrive at your place of business, and you call to check on delivery, we have no way of finding out where the package is or when it may be delivered.....if ever. Together, we then have the difficulty of sorting out who is responsible for a package that hasn't arrived and may, or may not be lost.

Northwest Tag & Label ships several hundred packages daily. The only workable shipping method is one that picks up at our printing facility, allows constant tracking of a package from our business to yours, and provides insurance against loss; as well as a definitive method of determining **when** a package is lost so a replacement shipment can be made. UPS is the cost effective way to ship small packages that meets the above criteria. Packages are electronically scanned at Northwest Tag & Label, then scanned at each stop throughout the delivery path to you. That information is readily available via our Internet connection so we can tell you exactly where your package is, and approximately when it will be delivered.

With the tracking number and an Internet connection, you can even track the package yourself. Just ask us to email the UPS tracking number when the package ships.
